## CABRI Policy Dialogue

### *Value for Money in WASH - policy challenges and opportunities for improved service delivery*

The CABRI Policy Dialogue aims to strengthen the linkages between Ministries of Finance and Ministries in charge of Water, Sanitation and Hygiene (WASH). Understanding their complementary roles in policy and financing improves the provision of quality services for better WASH outcomes. Building on previous dialogues in the health sector, CABRI is inviting African budget and WASH policy officials to discuss policy challenges in the WASH sector. The aim of the dialogue is to share ideas and obtain an in-depth understanding of the policy and institutional challenges in the WASH sector and to find cost effective ways to finance the sector. The dialogue also aims to improve the communication and mutual understanding between finance and the relevant WASH ministries.

*Session objective:* To draw out key issues in WASH funding and financing at the regional and country levels, framed by an introductory presentation. Participants are then encouraged, in small groups with participants from the same country, to discuss the following focus questions:

- In your country, is there reliable data on how much is spent in the sector, and from which sources (e.g. households, gov't budget, donors, commercial banks etc.)?
- What are the reasons for underinvestment in WASH in your country?
- What are the best realistic options for tapping additional sources of funding in your country to meet the WASH SDGs?
