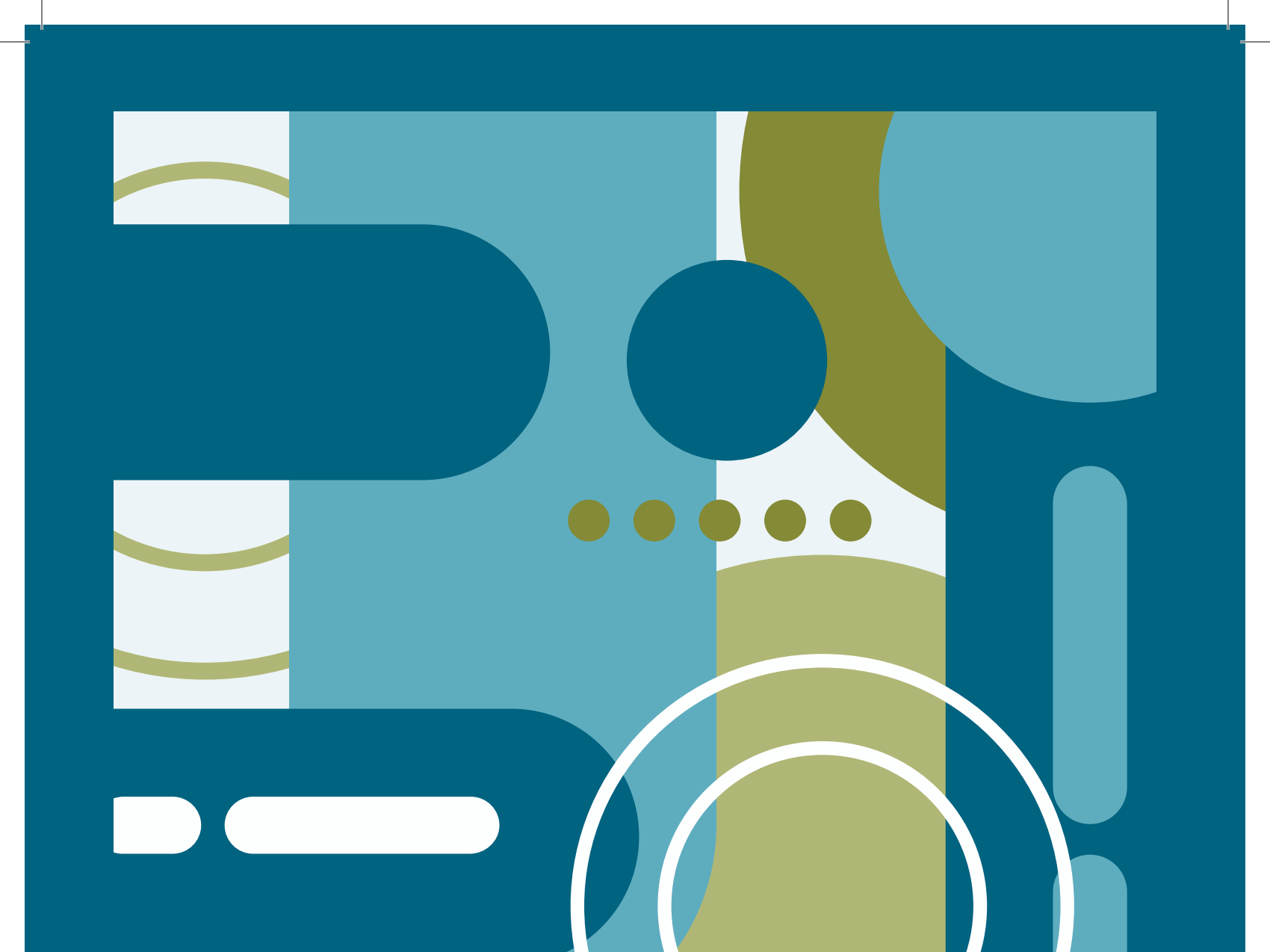

CABRI is an international organisation that partners with ministries of finance, line ministries and other government entities, to strengthen public finance capabilities and systems across Africa.

Recognised as a leading and credible pan-African voice on Public Financial Management (PFM) reform, CABRI works with over 35 African countries annually and supports governments through PFM initiatives including capacity building, expert guidance in debt and cash management, evidence-based knowledge generation and dynamic Policy Dialogues on emerging and critical PFM topics.



Vision

An African continent where public financial resources are mobilised and managed with transparency and accountability to drive efficient and effective service delivery, sustainable economic growth and development.



Mission

To empower African governments in designing and implementing effective PFM systems, policies and practices through collaborative peer-learning, locally driven solutions and dynamic networks of senior budget practitioners – with the aim of realising good governance and integrity in PFM.

From inception to expansion

Inception

1998–2004

- CABRI's inception through an informal network of budget managers.
- A Memorandum of Understanding signed by 11 countries.
- Targeted responses to budget managers' needs.
- Annual seminars, with 16 to 20 countries in attendance.

Niche

2005–2009

- Consolidating peer-to-peer learning and exchange networks.
- Agreement to establish an inter-governmental body governed by practitioners.
- Focusing on 'what works – when and how'.

Recognition

2010–2014

- Shaping of the global agenda on PFM and aid.
- Adding new approaches that focus on country practices.
- Annual average participation of 34 countries.

Application

2015–2016

- Minimum of 15 activities per year.
- Focusing on budget system functionality.
- Introducing work on public debt management.

Advancement

2017–2023

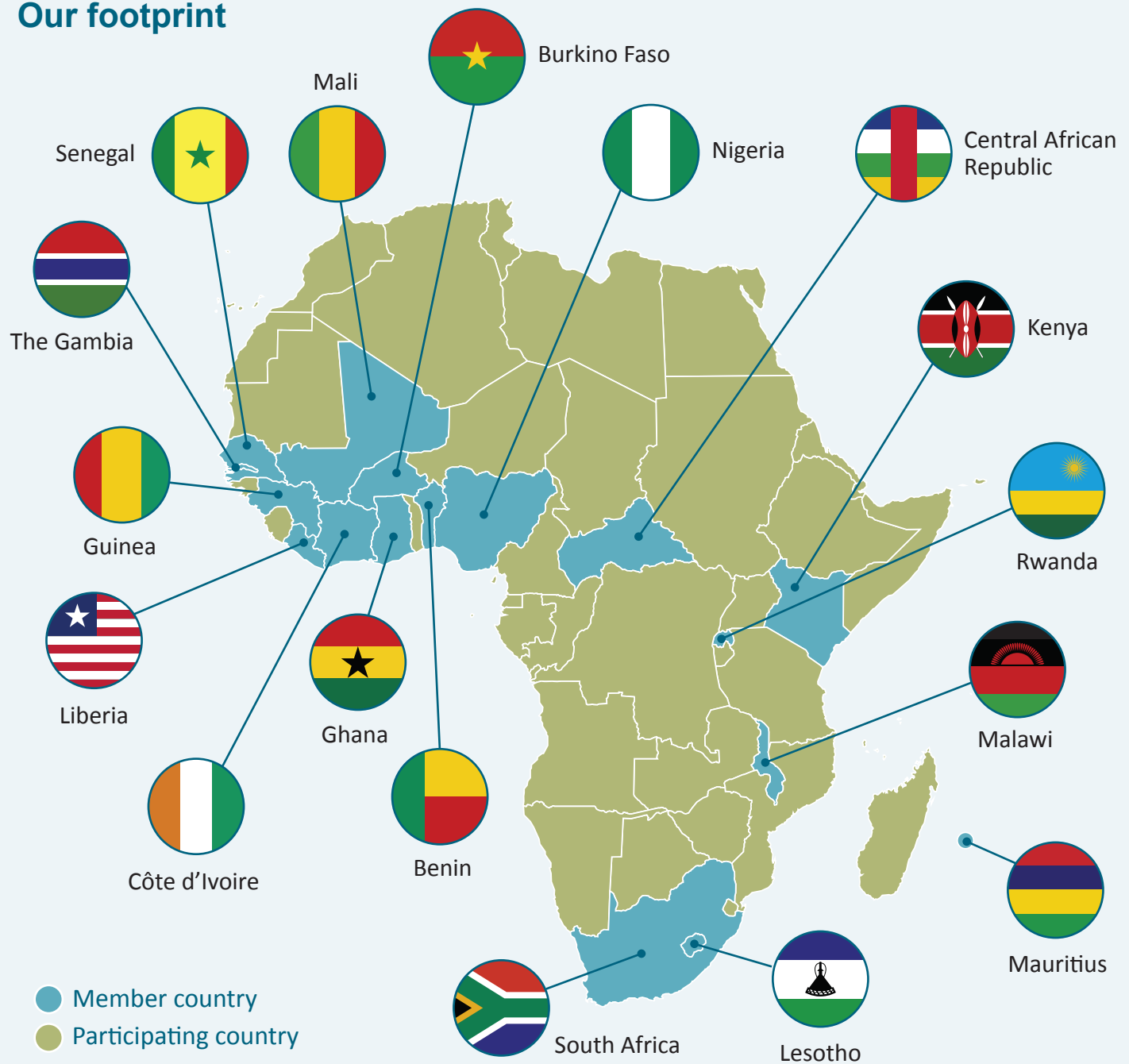
- Introducing and institutionalising the Building Public Finance Capabilities (BPFC) programmes, founded on the Problem-Driven Iterative Adaptation (PDIA) approach.
- Continued support for building the institutional capabilities of CABRI Member Countries.
- Institutionalising peer-learning through the CABRI Policy Dialogues.

Expansion

2024 onwards

- Repositioning CABRI to expand country support in response to emerging challenges faced by Member Countries.
- Focusing on the financial sustainability, modernisation and efficiency of operations.
- Rigorous monitoring and evaluation of the impact of CABRI's PFM initiatives.
- Maturation of CABRI's customised methodological approaches towards strengthening leadership development within the BPFC offering.

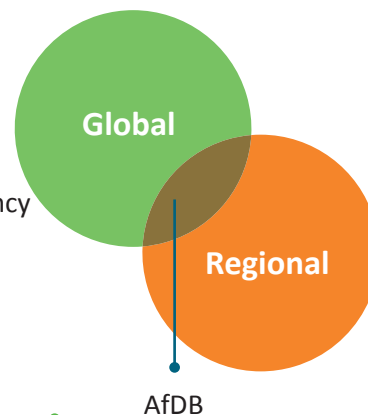

Membership benefits

CABRI membership is open to all African countries, with participation in some programmes/activities reserved for member countries. The benefits of being a CABRI Member Country include:

- Promoting locally driven solutions to local problems.
- Preferential selection to participate in the Building Public Finance Capabilities (BPFC) programme.
- Access to unique PFM approaches such as the Problem-Driven Iterative Adaptation (PDIA) approach.
- Access to a network of practising peers.
- Ministry staff development and training – targeted workshops and training conducted through peer-learning and exchange.
- Advocacy for African voices and ownership.
- Active participation in shaping CABRI's strategic direction through representation on the Management Committee and General Assembly.
- Access to learning resources and technical expertise.
- Being part of a collective effort to strengthen African public institutions.

Membership procedures

All African countries are invited to become a member of CABRI. Membership is formalised through accession to the International Agreement establishing CABRI, as per the following steps.*

STEP 1

Approval of the International Agreement establishing CABRI by Cabinet, Parliament or the relevant Minister

STEP 2

Accede to the International Agreement establishing CABRI

STEP 3

Submit the Accession Instrument to the CABRI Secretariat

STEP 4

Membership becomes effective upon receipt of the Accession Instrument

STEP 5

Agree to pay the membership fee as outlined below.
