# Introduction and Session objective(s)

Integrating gender into climate responsive budgeting is increasingly recognised for its ability to ensure the more effective, efficient and equitable use of public financial resources. Governments and civil society organisations from Africa, Asia and Latin America have been working to support a more inclusive approach to climate budgeting. Gender responsive climate budgeting initiatives span the entire budget cycle

(formulation, approval, oversight and policy review). The session brings together different perspectives from the global South on how gender responsive climate budgeting can be implemented for sustainable and inclusive development.

Countries will present and share lessons from respective gender and climate change reforms.

The session will include insights from,

- Ministry of Finance Rwanda, on how national budgeting and financing are gender and climate responsive
- Ministry of Women and Children Affairs Bangladesh, on reforms implemented to strengthen gender and climate change in budget formulation, approval and execution.
- Climate Policy Initiative, on lessons from Mexico from institutionalising gender and climate change into budgeting and financing

# Objectives:

- For developing countries to share good practice, opportunities and challenges for the "double mainstreaming" of climate and gender into the budget process.
- For development partners to agree on strategies to support innovative country level work in a harmonized way and share good practice.

## Key messages - what participants are expected to come away with/learn

- Gender budgeting and climate budgeting can learn from each others' successes and challenges.
- Double mainstreaming of gender and climate in the budget process is a new area but good practice is emerging
- Double mainstreaming requires skills that combine gender, climate and budgeting which needs a multi-disciplinary approach and institutional innovation
