**AGREEMENT ESTABLISHING THE COLLABORATIVE AFRICA BUDGET
REFORM INITIATIVE**

WHEREAS the Agreement Establishing the Collaborative Africa Budget Reform Initiative was concluded on 24 June, 2007, and entered into force;

AND WHEREAS article 19 of the Agreement provides that any African State may accede to the Agreement;

AND WHEREAS it is the wish of the Government of Malawi to accede to the Agreement;

NOW THEREFORE, I DR LAZARUS McCARTHY CHAKWERA, President of the Republic of Malawi, for and on behalf of the Government of the Republic of Malawi, DO HEREBY notify and confirm, in accordance with article 19, that the Republic of Malawi accedes to the Agreement.
